CHAPTER I

General Provisions

- Art.1. This Methodology regulates, at IOSUD-West University of Timișoara, the definitive international academic mobility of doctoral students, foreign or Romanian citizens studying abroad, or foreign citizens studying in Romania.
- Art. 2. The definitive international academic mobilities of doctoral students can be organized under

the specific conditions regarding the admission to doctoral studies in Romania, in general, and at IOSUD - West University of Timișoara in particular, according to the National Education Law no. 1/2011, the Code of doctoral studies, the WUT Institutional Regulation on the organization and conduct of doctoral studies approved by HS no. 33 of 18.02.2021, the Order of the Ministry of National Education no. 5140/2019 of 11 September 2019 for the approval of the Methodology on academic mobility (published in Monitorul Oficial, Part I no. 744 of September 12, 2019) and the Order of the Ministry of National Education no. 3473/2017, of 17.03.2017, on the approval of the Methodology for the admission to studies and schooling of foreign citizens starting with the school/university year 2017-2018 (published in Monitorul Oficial, Part I, no. 233 of April 05, 2017), the Order of the Ministry of Education no. 3325 of March 02, 2022 on the completion of the Annex to the Order of the Minister of Education no. 5140/2019 for the approval of the Methodology on the academic mobility of students (published in the Official Gazette No. 209 of March 2022), Circular No. DGRIAE- 474/CMJ/3 March 2022, Emergency Ordinance No. 20/07.03.2022 (published in the Official Gazette No. 231/08.03.2022).

CHAPTER II

Conditions and procedures for the definitive international academic mobility of doctoral students

Art. 3. IOSUD-WUT accepts doctoral students enrolled in higher education institutions from the European Union, the European Economic Area, the Swiss Confederation and from EU third countries or doctoral students who are foreign citizens enrolled in higher education institutions in Romania, according to the legislation in force, in the conditions established by this Methodology, only if they come from accredited institutions in the countries in which they are working, the study programmes followed by the respective students are also accredited and endorsed by the competent national and/or international bodies, and their diplomas are recognized in Romania (according to the annexes to the Methodology for the admission and enrolment of foreign citizens in accredited state and private pre-university education units/institutions of higher education).

Art. 4. The mobility will be based on a file submitted to the WUT Doctoral Studies Office with the support of the International Relations Department of the West University of Timisoara. The file will include the documents mentioned in the following articles, depending on the candidate's status. All documents not issued in Romanian, English or French will be accompanied by a translation into one of these languages.

Art. 5. The definitive academic mobility at IOSUD-WUT can be carried out within the same doctoral field, between accredited doctoral schools, taking into account:- The agreement of the IOSUD-WUT doctoral supervisor - The number of places assigned to the IOSUD-WUT doctoral supervisor (maximum 8)- The reasons for the request for the definitive mobility. The doctoral student will submit documents proving the level of training achieved during the doctoral studies (according to the doctoral study plan completed together with the coordinator of the university from which he/she comes or another similar document, containing at least a list of subjects studied and reports defended). The mobility application (together with the

supporting documents) will be analyzed and approved/rejected by a Commission composed of the Director of the CSUD, the Director of the Doctoral School of the field of the PhD in which the definitive mobility is to be carried out and the supervisor who accepted the supervision. The WUT is responsible for verifying the authenticity of the documents through direct correspondence with the educational institutions issuing the partial study documents, through the Doctoral Studies Office and/or the International Relations Department. The Commission will forward the decision taken, together with the mobility file, to the BSD and DRI within a maximum of two weeks of its receipt, in order to support the student and to be able to take further steps (to the Ministry of Education, if necessary).

- Art. 6. The responsibility for finalizing the academic situation at the home institution is the responsibility of the doctoral student applying for mobility, the WUT not being involved in this process.
- Art. 7. At the moment of the beginning of the doctoral student's definitive mobility, the director of the CSUD applies the recognition of credits for the training program based on advanced university studies, if applicable, and/or the recognition of the research program upon the proposal of the IOSUD-WUT doctoral supervisor. The latter shall also now propose the composition of the doctoral student's mentoring committee for the doctoral student coming from a definitive international academic mobility. If the doctoral supervisor deems it necessary, the doctoral student may take other examinations or research reports, with the corresponding modification of the doctoral study program.
- Art. 8. At the time of applying for mobility from a higher education institution abroad, candidates applying for mobility must meet any specific condition required for admission to the WUT, if it is related to their access to education in a higher education institution in Romania, as follows:
- 8.1. Candidates of Romanian nationality who have previously studied abroad must include in the mobility file the opinion on the recognition and equivalence of previously completed studies (Master's degree studies) from the National Center for the Recognition and Equivalence of Diplomas of the Ministry of the relevant Ministry in Romania. They will no longer be admitted to the West University of Timişoara, but will be enrolled on the basis of the mobility file including the attestation issued by CNRED, in the academic year for which the transfer is requested, based on the evaluation made by the committee appointed by IOSUD-WUT.
- 8.2 Applicants who are citizens of the European Union, the European Economic Area and the Swiss Confederation, other than Romanian citizens, and who have studied abroad, must include in the mobility file the opinion on the recognition and equivalence of previously completed studies (Master's degree studies) issued by CNRED of the Romanian Ministry of the relevant Ministry. They will no longer be admitted to the West University of Timisoara, but will be enrolled on the basis of the transfer file including the attestation issued by CNRED, in the

academic year for which the transfer is requested, based on the equivalence of the evaluation made by the committee appointed by IOSUD-WUT.

- 8.3. Candidates who have studied at higher education institutions in non-EU, EEA and Swiss Confederation third countries will be able to transfer taking into account the legislation in force and any international inter-governmental agreements in this regard, as follows: Foreign citizens who have completed partial studies in another state may continue their studies in accredited higher education in Romania, at doctoral level, if: they have documents proving their foreign citizenship; they have graduated with a diploma (or equivalent) from a master's degree program; they have been enrolled at a higher education institution recognized by the authorities of the respective state; they have documents proving the level of training achieved in the doctoral studies (according to the doctoral study plan completed together with the coordinator of the university from which they come or another similar document, containing at least a list of subjects studied and reports defended); they have the WUT's acceptance for the definitive international academic mobility. The mobility file will contain, in addition to the required documents: application for the Letter of Acceptance for the West University of Timisoara, internationally recognized medical certificate showing that they are not suffering from contagious diseases or other medical conditions; official documents showing the grading system applied in the institution where they studied previously. The admission procedure for these candidates is as follows: applications are sent directly to the WUT; the WUT evaluates the applications according to the present methodology and transmits to the ME-DGRIAE the list of persons proposed for the issuance of the Letter of Acceptance to study and the copy of the applications which will include the decision of the Commission appointed by the IOSUD-WUT, by September 15 of each year; the number of applications submitted must be within the limit of 10% over the number of places approved by the Ministry of Education for IOSUD-WUT for the respective academic year, ME issues the Letter of Acceptance to study and sends it to the higher education institutions, this being the only document necessary and mandatory for the matriculation in Romania of these students.
- 8.4. Candidates who have studied at higher education institutions in EU third countries (Ukraine), given the geopolitical context in this country, will be able to transfer in 2021-2022 and 2022-2023 taking into account the legislation in force and any international intergovernmental agreements in this regard, as follows:
- If the doctoral student cannot prove the studies completed by documents issued by the higher education institution he/she previously attended in Ukraine, the WUT shall evaluate the learning outcomes, competences and skills (including language) on the basis of an interview and a research project submitted by the doctoral student (if he/she is in the first year) or on the basis of an interview and a doctoral research report submitted by the doctoral student (if he/she is in the second year).
- The doctoral student in this situation must submit to the WUT, before the end of his/her studies, the academic documents (master's degree or its equivalent) that allowed him/her to enter the doctoral program.

- In order to be eligible for permanent international academic mobility, candidates must provide either proof of enrolment in one of the recognized higher education institutions in Ukraine (e.g. residence permit proving student status, student card physical or electronic format, doctoral study plan or equivalent study document) or a sworn statement that they will present these documents in the following period (Annex 3). The list of higher education institutions in Ukraine can be consulted at
- https://www.whed.net/results_institutions.php;
- http://www.enic.in.ua/index.php/en/educationl-system/higher-education.

The mobility file for Ukrainian citizens or citizens of other countries studying in Ukraine in the academic year 2021-2022 and wishing to continue their studies at WUT will contain:a) if the applicant has study documents, the application file will be submitted in accordance with the provisions of the Methodology of admission to study and tuition of foreign citizens starting with the academic/university year 2017-2018, as amended and supplemented. To these documents will be added the Mobility Application (Annex 2) of this Methodology approved by the West University of Timisoara.b) In case the applicant does not have study documents, the WUT will prepare a file for each applicant, which will include: copies of identity documents, the result of the assessment made by IODUD, with the provisions of OME 3325/2.03.2022, the university's proposals for enrolment in the study program, the year of study and the language of instruction, a sworn statement on the assumption of the obligation specified in art. (3) of Annex OME 5140/2019 with subsequent amendments and additions. The Mobility Application (Annex 2) to this Methodology approved by the West University of Timisoara shall be added to these documents. In the academic years 2021-2022 and 2022-2023, academic mobility for citizens of third countries of the European Union from recognized higher education institutions in Ukraine is carried out as a result of the student's own initiative, with the consent of the WUT. The final academic mobility of these students is carried out, for a fee, according to Law no. 1/2010 for the approval of Government Ordinance no. 22/2009 on the establishment of the minimum amount of tuition fees, in foreign currency, for citizens studying on their own in Romania, from countries that are not members of the European Union, as well as from countries that are not part of the European Economic Area and the Swiss Confederation. In the case of students transferring to the WUT from higher education institutions in Ukraine and studying on their own in Romania in 2021-2022, the fee paid for 2021-2022 will be calculated as the number of months spent at the WUT * the amount of the monthly fee according to OG no. 22/2009 for the respective field of study. In the academic years 2021-2022 and 2022-2023, by exception from the above provisions, students, citizens of Ukraine, may receive funding from the state budget or from other sources through the Ministry of Education and higher education institutions, respectively, according to art. 224 of the Law No. 1/2011 on National Education, as amended and supplemented.

The definitive mobility procedure applied to these candidates is as follows: IOSUD-WUT evaluates the files according to the regulations in force and forwards to DRI WUT, which, in turn, forwards to ME-DGRIAE the list of persons proposed for the issuance of the Letter of Acceptance to study and the decision of the Commission appointed at IOSUD-WUT level during the second semester of the academic year 2021-2022 and in the academic year 2022-2023; the number of files forwarded must fall within the limit of the number of places approved by the Ministry of Education for IOSUD-WUT in the respective academic year according to

the Emergency Ordinance no. 20/07.03.2022 (published in Monitorul Oficial no. 231/08.03.2022); thereafter, the MoE issues the Letter of Acceptance for studies and forwards it to the WUT.Permanent mobility to the WUT cannot be realized in cases of students in the terminal year (3rd year or extension) of doctoral studies at a higher education institution in Ukraine. In these situations it is recommended to participate in the 2022 admission to doctoral studies in the same field at the WUT, with the mention that the WUT will offer the possibility of equivalence of the doctoral study plan at the level reached before the mobility and enrollment in the final year of study in Romania in 2022-2023.

In the case of EU citizens enrolled at a higher education institution in Ukraine applying for permanent mobility in 2021-2022 and 2022-2023, the procedures of point 8.2. regarding mobility with recognition and equivalence of previous study documents will be applied, but the applications can be submitted within the timeframe established for this exceptional situation (art.10).

- Art. 9. Doctoral students who are foreign citizens and who apply for permanent mobility to the WUT from a higher education institution in Romania will be transferred as follows:
- 9.1. Doctoral students who are citizens of the European Union, the European Economic Area and the Swiss Confederation already studying in Romania will be transferred under similar conditions to Romanian doctoral students.
- 9.2. Students who are foreign citizens of Romanian ethnicity from the Diaspora or the Republic of Moldova who are already studying in Romania and who benefit from the status of scholarship holders of the Romanian state will be transferred according to the Methodology in force regarding this category of students, with the consent of the legal representatives of the educational institutions involved, maintaining their status and the financial regime in which they are studying, respecting the principle of "the grant follows the student".
- 9.3 Students who are foreign citizens from non-EU member states of the European Union, the European Economic Area and the Swiss Confederation already studying in Romania will apply for a new Letter of Acceptance to Study in Romania, for studies at the WUT, according to the principle of "definitive internal mobility" (OM no. 5140/2019 for the approval of the Methodology on the academic mobility of students, with the acceptance of the accredited higher education institutions of origin, respectively receiving, as well as with the agreement of the MoE). The mobility file will contain, in addition to the required documents: application for the WUT Letter of Acceptance, a copy of the residence permit, attestation of knowledge of the language in which the doctoral student will work (according to the European Framework of Reference for Modern Languages, issued by a higher education institution accredited for the Preparatory Year, for Romanian or by an accredited higher education institution for English, French or German). Upon request, this attestation may be issued by authorized departments within the Faculty of Letters, History and Theology of the WUT. The admission procedure for these candidates is as follows: IOSUD-WUT evaluates the applications in accordance with the regulations in force and forwards to DRI WUT, which in turn forwards to ME-DGRIAE the list of persons proposed for the issuance of the Letter of Acceptance to Studies and the decision of the Transfer Commission, by September 15 of each year; the number of applications submitted must be within the limit of 10% of the number of places approved by the Ministry of Education

for IOSUD-WUT in the respective academic year; thereafter, the MoE issues the Letter of Acceptance to Studies and sends it to the WUT, this being the only document necessary and mandatory for the registration in Romania of this category of students.

Art. 10. IOSUD-UWUT accepts applications for definitive international academic mobility only at the beginning of the semester, after the first semester and until the end of the penultimate semester, between similar doctoral fields. Enrolment is carried out at the beginning of the semester for which the transfer is requested, no later than two weeks after the beginning of the semester, according to WUT Regulations. In the case of doctoral students applying for definitive international academic mobility at WUT from higher education institutions in Ukraine, the following deadlines apply: for the academic year 2021-2022, until April 15, 2022; for the academic year 2022-2023, between July 1, 2022- September 15, 2022.Art. 11. The mobility file must be submitted to the Doctoral Studies Office, with the support of the WUT International Relations Department, at least 30 days before the beginning of the semester for which the transfer is requested. The file will contain:

- 1. Application for mobility (Annex 1) or written agreement of the home institution;
- 2. Documents proving the level of training achieved in the doctoral studies (according to the doctoral study plan completed with the coordinator of the home university or other similar documents includin a list of studied subjects and presented reports).
- 3. Copy of the bachelor's degree, transcript of records and master's degree or its equivalent and legalized translations if they are not issued in Romanian, English, French;
- 4. Motivation letter; CNRED certificate on the recognition of the Master's degree (only Romanian citizens with diplomas obtained abroad, citizens of the European Union, European Economic Area and Swiss Confederation);
- 5. Letter of acceptance to study in Romania for the institution of origin (only citizens of non-EU countries enrolled under the CPV regime or benefiting from a Romanian state scholarship, other than citizens of non-EU countries who are Romanians from abroad foreign citizens of Romanian ethnicity or Romanian citizens residing abroad who benefit from the status of "Romanian state scholarship holders");

Copy of the Order of the Minister regarding matriculation at the institution of origin (only Romanian students from abroad - foreign citizens of Romanian ethnicity or Romanian citizens residing abroad who benefit from the status of "Romanian state scholarship holders");

6. Identity documents (birth certificate and passport proving residence abroad, in the case of foreign citizens).
